This addendum to prospectus for bonds issued in pursuance of section 33 e of the Danish Mortgage-Credit Loans and Mortgage-Credit Bonds etc. Act (junior covered bonds) by Nykredit Realkredit A/S is published in connection with the publication of the Q1-Q3 Interim Report 2011 of the Nykredit Realkredit Group. The Interim Report was published by stock exchange announcement today, to which reference is made.

Part III of the prospectus "Information about Nykredit" has been changed as follows:

Clause 3.2 Selected financial information

Previous references to interim reports have been deleted.

Instead, the following text has been inserted:

"Reference is made to the Q1-Q3 Interim Report 2011 available at Nykredit's website nykredit.com. The report has not been audited."

Clause 7.2 Business outline

The current clause 7.2 has been replaced by the following:

"Nykredit has adopted a strategy and organisation to pave the way for significant business development and growth over the next 4-5 years. The future growth will chiefly be generated in the banking area, for which reason Nykredit Bank is an important entity of the Nykredit Group. Total-kredit is also strategically important to the Nykredit Group as the bulk of the Group's mortgage lending for retail customers takes place through Totalkredit.

Funding of lending in Totalkredit A/S takes place in Nykredit in accordance with authorisation from the FSA. For a detailed review, reference is made to "Intercompany funding" (clause 5.4.1) and "Joint funding" (clause 5.4.2) above."

Clause 13.5 Interim and other financial information

The current clause 13.5 has been replaced by the following:

"Nykredit prepares and publishes interim reports. Interim reports are not audited and are available to the public at Nykredit's website nykredit.com.

Reference is made to the Q1-Q3 Interim Report 2011 available at Nykredit's website nykredit.com. The report has not been audited."

Appendices A and B have been updated and attached to this addendum.
