# Part IV of the prospectus "Bond information" has been changed as follows:

In item 7.5, the existing text has been deleted and replaced by:

"Mortgage bonds issued out of Capital Centre D are rated AAA by Standard & Poor's Credit Market Services ("S&P").

Nykredit emphasises that the rating may be subject to changes.

The issuer rating assigned to Nykredit by S&P – ie independently of the rating assigned to bonds issued under this prospectus – is A+.

S&P is registered as a credit rating agency of the EU in pursuance of Regulation (EC) No 1060/2009 of the European Parliament and of the Council of 16 September 2009 on credit rating agencies."
