Addendum to prospectus of 5 March 2009 for the offering of ROs in Nykredit Realkredit A/S

This addendum to prospectus for the offering of ROs in Nykredit Realkredit A/S is published in connection with the decision of the Danish Competition Appeals Tribunal of 2 December 2010 on Nykredit's administration margins. The decision is described in detail in a stock exchange announcement dated 3 December 2010 to which reference is made.

Part III of the prospectus "Information about Nykredit" has been changed as follows:

Item 13.6. Legal and arbitration proceedings

The existing text concerning the case about Nykredit's administration margins has been deleted in its entirety and replaced with:

"In February 2010, Nykredit announced that it would increase margins on both new and existing retail mortgages.

In June 2010, the Danish Competition Council temporarily overruled Nykredit's decision to increase administration margins as intended with reference to Nykredit's undertaking concerning administration margin adjustments in connection with its acquisition of Totalkredit in the autumn of 2003. The Danish Competition Appeals Tribunal upheld the decision of the Danish Competition Council on 2 December 2010.

Nykredit disagrees with the Danish Competition Appeals Tribunal that the announced administration margin increase conflicts with the undertaking given in the autumn of 2003. Accordingly, Nykredit will bring the case before the courts.

The Danish Competition Council has previously indicated that, under the circumstances and because of the nature of the undertaking and the time passed since it was made, it will examine whether market and regulatory conditions have changed to such an extent that the undertaking should be cancelled or changed. In addition to bringing the case before the courts, Nykredit will therefore continue its dialogue with the Danish Competition Council in the hope of solving the case in this way."
