Addendum to prospectus of 5 March 2009 for the offering of ROs in Nykredit Realkredit A/S

This addendum to prospectus for the offering of ROs in Nykredit Realkredit A/S is published in connection with the publication of the Q1 Interim Report 2009. The Q1 Interim Report 2009 has been published by stock exchange announcement dated 7 May 2009 to which reference is made.

Part III of the prospectus "Information about Nykredit" has been changed as follows:

Item 3.2. Selected financial information

Previous references to interim reports have been deleted.

Instead, the following text has been inserted: "Reference is made to the Q1 Interim Report 2009, available at Nykredit.com. The Q1 Interim Report 2009 has not been audited."

In item 7.1 "Organisational Structure", the existing text has been deleted in its entirety and replaced with:

"Nykredit is wholly-owned by Nykredit Holding A/S. Foreningen Nykredit is the principal shareholder of Nykredit Holding A/S."

The Nykredit Holding Group's business activities are undertaken by Nykredit and Nykredit's subsidiaries

Nykredit carries on mortgage banking activities. Nykredit is also licensed by the FSA to carry on business as a securities dealer.

Nykredit's subsidiary Totalkredit carries on mortgage banking activities.

Nykredit carries on other financial business through its subsidiaries Nykredit Bank A/S (and subsidiaries), Forstædernes Bank A/S and Nykredit Forsikring A/S. Nykredit has a branch in Poland.

Nykredit carries on business relating to mortgage banking through its subsidiary Nykredit Mægler A/S.

All Nykredit's subsidiaries are wholly owned, including Forstædernes Bank A/S, as the redemption period for shares issued by Forstædernes Bank A/S expired on 2 April 2009.

See also the organisational chart in the Annual Report for 2008 of the Nykredit Realkredit Group. As a subsidiary of Nykredit Realkredit A/S, Forstædernes Bank A/S appears on a par with Nykredit Bank A/S in the organisational chart.

In item 7.2 "Business outline", the existing text has been deleted in its entirety and replaced with:

"Nykredit's business activities are independent of other Group units. See also the published Annual Report for 2008 of the Nykredit Realkredit Group.

Reference is made to the Q1 Interim Report 2009, available at nykredit.com. The Q1 Interim Report 2009 has not been audited."

Item 13.5. Interim and other financial information

Previous references to interim reports have been deleted.

Instead, the following text has been inserted: "Reference is made to the Q1 Interim Report 2009. The Q1 Interim Report 2009 has not been audited."

Item 13.6. Legal and arbitration proceedings

With regard to the pending tax case, the amount to be recognised as income if the court finds for Nykredit has been changed from DKK 171m to DKK 156m.
