# Addendum to prospectus of 15 November 2007 for the offering of SDOs in Nykredit Realkredit A/S

In connection with the publication of the Annual Report for 2010 of the Nykredit Realkredit Group, an addendum to the Prospectus for the offering of SDOs in Nykredit Realkredit A/S is published. The Annual Report was published by stock exchange announcement dated 10 February 2011, to which reference is made.

### Part III of the prospectus "Information about Nykredit" has been changed as follows:

*In item 3.1 Selected financial information*, the reference to "the last audited and published annual reports for 2008 and 2009" has been deleted and replaced with a reference to "the last audited and published annual reports for 2009 and 2010".

*In item 3.2 Selected financial information,* the reference to "the last published interim reports for 2008 and 2009" has been deleted and replaced with a reference to: "the last published interim reports for 2009 and 2010."

*In item 7.1 Organisational structure,* the reference to "Annual Report for 2009" has been deleted and replaced with a reference to "Annual Report for 2010."

*In item 7.2 Organisational structure,* the reference to "Annual Report for 2009" has been deleted and replaced with a reference to "Annual Report for 2010".

*I punkt 9.1. Resultatforventninger eller prognoser* slettes referencen til "årsrapport for 2009" og erstattes af en reference til "årsrapport for 2010."

*In item 13.1 Historical financial information,* the following reference has been deleted: "the last two audited and approved annual reports for 2008 and 2009" and replaced with: "the last two audited and approved Annual Reports for 2009 and 2010."

#### Item 13.6. Legal and arbitration proceedings

Following the decision regarding Nykredit being liable to pay tax on profits from the disposal of shares in the financial years 1999, 2000 and 2001, the following text has been deleted:

"On 30 June 2005 the Danish National Tax Tribunal found for Nykredit and held that Nykredit should not be liable to tax on profits from the disposal of shares held for trading purposes in the financial years 1999, 2000 and 2001. The Danish Ministry of Taxation subsequently brought the case before the ordinary Danish courts. The Danish Ministry of Taxation claimed that part of Nykredit's portfolio of shares was acquired in connection with the trading activities, and therefore Nykredit's gains and losses on the sale of shares as from 1999 were to be declared in Nykredit's income statement. As the Danish Ministry of Taxation changed its claim, Nykredit no longer foresees an additional expense relative to the tax charge already made in the Annual Report for 2006. Nykredit has requested the court to find in its favour. Nykredit expects the Danish court to find for Nykredit. If the court finds for Nykredit, deferred tax of DKK 101m will be recognised as income."

Instead, the following text has been inserted:

"On 1 February 2011, the Danish High Court delivered judgment in the tax case brought before the courts by the Danish Tax authorities against Nykredit Realkredit. The High Court found for Nykredit Realkredit on all counts. The period allowed for appeal expires in March 2011. If the Danish tax au-

thorities do not appeal the judgment to the Danish Supreme Court, Nykredit Realkredit will be able to recognise deferred tax in the region of DKK 125m."

In relation to the case about Nykredit's administration margins, the following has been deleted:

"Nykredit disagrees with the Danish Competition Appeals Tribunal that the announced administration margin increases conflict with the undertaking given in the autumn of 2003. Accordingly, Nykredit will bring the matter before the courts."

Instead, the following has been inserted:

"Nykredit disagrees with the Danish Competition Appeals Tribunal that the announced administration margin increases conflict with the undertaking given in the autumn of 2003. Accordingly, Nykredit has brought the matter before the courts."
