Addendum to prospectus of 15 November 2007 for the offering of SDOs in Nykredit Realkredit A/S

In connection with the publication of the Q1-Q3 Interim Report 2008 of the Nykredit Realkredit Group, an addendum to Prospectus for the offering of SDOs in Nykredit Realkredit A/S is hereby published. The Q1-Q3 Interim Report 2008 has been published by stock exchange announcement dated 6 November 2008 to which reference is made.

Part III of the prospectus has been changed as follows:

Item 3.2. Selected financial information

Previous references to interim reports have been deleted.

Instead, the following text has been inserted: "Reference is made to the Q1-Q3 Interim Report 2008. The Q1-Q3 Interim Report 2008 has not been audited."

Item 7.2. Business outline

Previous references to interim reports have been deleted.

Item 13.5. Interim and other financial information

Previous references to interim reports have been deleted.

Item 13.6. Legal and arbitration proceedings

With regard to the pending tax case, the amount to be recognised as income if the court finds for Nykredit has been changed from DKK 177m to DKK 189m.

In connection with rating agency Standard & Poor's AAA rating of bonds issued under the prospectus, Part IV of the Prospectus has been changed as follows:

The following text has been inserted as a new item 3.3:

"Item 3.3. Collection accounts

Accounts shall be opened with banks having a Standard & Poor's rating of at least BBB+/A-2. If the account-holding bank no longer has at least a BBB+/A-2 rating from Standard & Poor's, the account will be transferred to a bank that meets this criterion within 30 days. If the account-holding bank no longer has a rating from Standard & Poor's, or if Standard & Poor's has never assigned a rating to the bank, Nykredit Realkredit A/S shall not transfer the account, provided that Nykredit Realkredit A/S can establish that the account with the account-holding bank has no negative consequences for the rating of SDOs issued pursuant to this basic prospectus. Irrespective of this provision, Nykredit Realkredit A/S may have balances in accounts with banks which have not been rated by Standard & Poor's up to a limit of DKK 100m per bank and DKK 500m in total."

Item 7.5 Further information The following has been deleted:

"SDOs under this prospectus have been assigned a Aaa rating by the credit rating agency Moody's Investors Service, Inc. The rating is available at Nykredit's website nykredit.com/ir and at Moody's website Moodys.com."

Instead, the following text has been inserted:

"SDOs under this prospectus have been assigned a Aaa rating by credit rating agency Moody's Investors Service, Inc. and a AAA rating by credit rating agency Standard & Poor's. The ratings are available at Nykredit's website nykredit.com/ir."
