

At 31 December 2019, the retention payment earned was DKK 11.3 million, payable over a 5-year period, the first payment was made in 2020. A retention payment of DKK 0.0 million for Michael Rasmussen (2022: DKK 0.0 million) was charged to the income statement in 2023.

² Nykredit Realkredit A/S has entered into retention agreements with each of Group Managing Directors Anders Jensen and David Hellemann. At 1 January 2021, the retention payment earned was DKK 4.3 million, payable over a 5-year period, the first payment was made in 2021. A retention payment of DKK 0.0 million for Anders Jensen and David Hellemann (2022: DKK 0.0 million) was charged to the income statement in 2023.
